Restatement (Second) of Contracts § 14 (1979). The second consideration is "the legal relationships of the parties to the contract" and the third is "the nature of the contract, as it is affected by the circumstances and conditions surrounding the parties at the time of making it." Id. Under both of these considerations, we have held that where there is no dispute that the parties intended to enter into a contract, nor that the purported contract is of a type that is recognized under the law, then the contract will be enforced to the extent that it is possible to do so under the circumstances of the case. ¶ 14 In making this determination, I would consider it appropriate to give weight to the facts that the group of landowners represented by Ms.

Pennington was being coerced into making a contract that they did not want to make. In addition, the landowner who held the westernmost piece of property, Mr. Johnson, was later imprisoned for a violation of his probation after a period of incarceration following a conviction for murder. I suspect that a court would consider this incarceration to be the basis for finding a mutual mistake to the agreement that the parties had reached, and thus would be justified in

concluding that there was no contract at all. The circumstances of these two cases are such that the recitals and operative provisions of the contract would not be enforceable in the circumstances of this case. We should not presume to read in terms that are not expressed in the agreement that was reached. ¶ 15 I would give effect to the contract that was actually entered into with the Johnson family, which would include the easements and the easement covenants, and the contract with the Penningtons and the other remaining landowners who both entered into the agreement voluntarily.
